

**Roads (Works, Use and Compensation) Ordinance (Chapter 370)**

**(Notice under section 8(2))**

**PWP Item No. 7786CL  
Tung Chung New Town Extension  
(Tung Chung East and Road P1 (Tung Chung East  
to Tai Ho Section) Road Works)**

Notice is hereby given that under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plans Nos. 60507694/C11/100 and 60507694/C11/110 to 60507694/C11/120 (“the Plans”) and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows –

- (i) construction of a dual two-lane Road P1 (Tung Chung East to Tai Ho section);
- (ii) construction of Tai Ho Interchange including slip roads connecting to North Lantau Highway and Cheung Tung Road;
- (iii) construction of a roundabout including slip roads connecting Road P1 and Tai Ho Interchange;
- (iv) construction of vehicular underpass, depressed carriageways, at grade carriageways and elevated carriageways;
- (v) extension of Pak Mong subway to Tung Chung East;
- (vi) construction of depressed footpaths, at grade footpaths, elevated footpaths, depressed cycle track, at grade cycle tracks, elevated cycle track, cycle parking areas, at grade amenity areas, elevated

amenity areas, central reserves/refuge islands, run-ins/run-outs and pedestrian crossings;

- (vii) permanent closure and conversion of sections of the existing at grade carriageways into at grade footpaths, at grade cycle track, at grade amenity areas and central reserves/refuge islands;
- (viii) permanent closure and conversion of sections of the existing elevated carriageways into central reserve/refuge island;
- (ix) permanent closure and conversion of a section of the existing subway into at grade amenity area;
- (x) permanent closure and conversion of sections of the existing at grade footpaths into at grade carriageways, at grade cycle tracks, at grade amenity areas and central reserve/refuge island;
- (xi) permanent closure and conversion of sections of the existing at grade amenity areas into at grade carriageways, at grade footpaths and central reserves/refuge islands;
- (xii) permanent closure and conversion of sections of the existing elevated amenity areas into elevated carriageways and central reserve/refuge island;
- (xiii) permanent closure and demolition of sections of the existing at grade carriageways, elevated carriageways and at grade footpath;
- (xiv) temporary closure and reconstruction of sections of the existing at grade carriageways, elevated carriageways, subway, at grade footpaths, at grade cycle track, at grade amenity areas, elevated amenity areas and central reserves/refuge islands;
- (xv) temporary closure of sections of the existing at grade carriageways, subway, at grade footpaths, at grade cycle track, at grade amenity

areas, elevated amenity areas and central reserves/refuge islands;  
and

- (xvi) ancillary works including geotechnical, slope stabilization, drainage, sewerage, water, utilities and landscaping works as well as construction of slopes, vertical noise barriers, cantilever noise barriers, retaining walls and underground pumphouse.


Any person who wishes to object to the works or the use, or both, is required to address to the Secretary for Transport and Housing an objection in writing, which can be submitted via one of the following means –

- (1) By post or by hand to the Transport and Housing Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);
- (2) By fax to (852) 2868 4643; or

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Housing not later than 24th day of July 2018.

### **Personal Information Collection Statement**

Any information, including the personal data, submitted to the Secretary for Transport and Housing in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
