This notice was affixed to the above-mentioned land on 25 July 2024. Upon expiration of the notice period at midnight on 25 October 2024, the above-mentioned land shall revert to the Government of the Hong Kong Special Administrative Region. The date of reversion shall be 26 October 2024.
