Roads (Works, Use and Compensation) Ordinance (Chapter 370)

PWP Item No. 7786CL Tung Chung New Town Extension – Design and Construction (Ma Wan Chung Road Works)

General Description of the Works

Under powers delegated by the Secretary for Transport and Housing under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ("the Ordinance"), the Permanent Secretary for Transport and Housing (Transport) proposes to execute the road works within the limit of works area as shown on Plan No. RD/GZ001 ("the Plan") annexed hereto and described hereunder. The proposed road works are required to serve the anticipated traffic demand induced by the Tung Chung New Town Extension Project.

- 2. The general nature of the proposed works is as follows
 - (i) modification of the junction of Tung Chung Road North, Chung Yan Road and Yat Tung Street;
 - (ii) construction of carriageways, footpaths, car parks, amenity areas, central reserves/traffic islands, a run-in/run-out and pedestrian crossings;
 - (iii) permanent closure and conversion of sections of the existing carriageways into footpaths, amenity area and central reserves/traffic islands;

- (iv) permanent closure and conversion of sections of the existing footpaths into carriageways, covered walkway, cycle track, car parks, amenity areas and central reserve/traffic island;
- (v) permanent closure and conversion of sections of the existing amenity areas into covered walkway, footpaths, cycle tracks and slope;
- (vi) permanent closure and conversion of sections of the existing central reserves/traffic islands into carriageways;
- (vii) permanent closure and conversion of sections of the existing staircases into carriageway, footpaths and car park;
- (viii) temporary closure and reconstruction of sections of the existing carriageways, footpaths and amenity areas;
- (ix) temporary closure and reconstruction of a section of the existing central reserve/traffic island;
- (x) temporary closure of sections of the existing carriageways, footpaths, amenity areas and central reserves/traffic islands; and
- (xi) ancillary works including site formation, landscaping, drainage, sewerage, water, street lighting and utilities works, construction of staircases and retaining walls, and installation of street furniture and traffic aids.

Roads to be Closed

3. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Housing (Transport) proposes that powers under section 17 of the Ordinance may be exercised to close permanently sections of the existing carriageways, footpaths, amenity areas, central reserves/traffic

islands and staircases; and temporarily sections of the existing carriageways, footpaths, amenity areas and central reserves/traffic islands within the limit of works area as shown on the Plan. Temporary alternative access will be provided and temporary diversions will be carried out during the construction period as and when required. Further notice, setting out the manner in which such carriageways, footpaths, amenity areas, central reserves/traffic islands and staircases are to be closed, will be issued under section 18 of the Ordinance as and when required.

Apparatus whose Course or Position to be Altered

4. For the purposes of or incidental to the works or the use, the Permanent Secretary for Transport and Housing (Transport) proposes that powers under section 20 of the Ordinance may be exercised to require alteration of the course or position of any existing utility service apparatus, such as electricity cables and ducts, telecommunication cables and ducts, water mains, stormwater drains, gas pipes and any other service apparatus lying within the limit of works area, and to require repairing of any road surface thereby disturbed. Further notice, setting out the manner in which the course or position of such apparatus is to be altered and such road surface is to be repaired, will be issued under section 20 of the Ordinance as and when required.
